THE COOPERATIVE ENVIRONMENTAL ASSESSMENT PROCESS PROPOSED WUSKWATIM GENERATION AND TRANSMISSION PROJECTS

Manitoba Hydro and Nisichawayasihk Cree Nation (the proponents) submitted two project proposals for licencing: the Wuskwatim Generation Project and the Wuskwatim Transmission Line Project. Manitoba and Canada agreed to and carried out a Cooperative Environmental Assessment Process pursuant to the Canada-Manitoba Agreement on Environmental Assessment Cooperation to review the two projects. Key dates/activities of the cooperative review process are outlined in Attachment 1.

Separate provincial and federal approvals are required.

- Manitoba Environment Act Licences are required for both projects.
- A federal comprehensive study is required under *The Canadian Environmental Assessment Act* (CEAA) for the Wuskwatim Generation Project.
- > Federal approvals are also required for stream crossings related to the access road to the generation site.

Manitoba was designated lead party for the cooperative process. The Manitoba Environment Act process (section 11 for the transmission project, section 12 for the generation project) was used to guide the cooperative process. These Clean Environment Commission (CEC) public hearings are a component of *The Environment Act* review process. Manitoba also established a participant assistance program to facilitate public involvement in the hearing process.

Fisheries and Oceans Canada (DFO) is the federal responsible authority (RA) for the federal environmental assessment. The RA will prepare a comprehensive study report (CSR) as required by the CEAA for public review. A thirty-day public review period is anticipated after which the CSR and any comments received from the public will be provided to the federal Minister of the Environment for a decision under CEAA. The CEC hearing will provide useful advice for the provincial licencing decisions and will be considered in the preparation of the CSR. To the extent possible, the provincial and federal final decisions will be coordinated.

A Project Administration Team (PAT) administered the cooperative review process. The PAT consists of: Larry Strachan (chair), Environmental Approvals Branch; Dan McNaughton, Canadian Environmental Assessment Agency; Trent Hreno, Environmental Approvals Branch; and Beverley Ross, Fisheries and Oceans Canada.

A Technical Advisory Committee (TAC) was in place to critically review all information generated in the environmental assessment and provide advice to the PAT and the proponents. Manitoba (Trent Hreno) chaired the TAC. Both federal and provincial representatives participate on the TAC. Information on the TAC process and membership is outlined in Attachment 2.

The proponents, following the environmental assessment guidelines submitted by the PAT, generated the necessary information required to meet the legal environmental assessment requirements of both the provincial and federal legislation. The information generated was a report on the 'need for and alternatives to' the projects, an environmental impact statement, two supplemental filings, and several specific reports to address Fisheries and Oceans Canada's requirements. The PAT also recognized and reviewed the substantial information that was generated by the interrogatory process administered by the CEC.

In consideration of all the information generated to date in the cooperative environmental assessment process, the PAT has concluded that:

- The intent and scope of the guidelines for the preparation of information on the 'needs for and alternatives to' and an environmental impact statement for the two projects have been satisfied;
- The environmental and technical information generated in the environmental assessment process is sufficient to be considered at the CEC public hearings;
- The environmental and technical information generated in the environmental
 assessment process is sufficient to address most of the requirements of the
 CSR. Further information has been provided by the proponents to address the
 remaining specific information requirements identified during the TAC
 review by DFO. This information is currently under review.

The PAT looks forward to receiving the advice and recommendations of the Clean Environment Commission following its public review. The advice and recommendations of the Commission will be carefully considered in any final regulatory decisions by Manitoba and Canada on the proposed projects.

Attachment 1

Wuskwatim Hydro Generation / Transmission Line Projects – Key Dates and Decisions

- 7 December 2001: Proponents submitted Environment Act Proposals for: 200 MW Generating Station on Burntwood River at outlet of Wuskwatim Lake (Class 3); and Transmission Line (Class 2).
- 11, 12, 18, 19 February 2002: Clean Environment Commission (CEC) conducted public consultation meetings on draft EIS Guidelines in northern Manitoba (Thompson, Nelson House, The Pas) and Winnipeg.
- 15 April 2002: Receipt of CEC Report on the Guidelines consultation acknowledged.
- 29 April 2002: EIS Guidelines finalized considering CEC recommendations and all technical and public comments.
- 2,3 and 4 June2002: Appeals filed on EIS Guidelines by Future Forest Alliance and Canadian Nature Federation
- 1 August 2002: Guidelines appeals dismissed.
- 28 April 2003: EIS documents submitted and subsequently placed in public registries and advertised.
- 30 April 2003: Need For and Alternatives To documents submitted and subsequently placed in public registries and advertised.
- 60-day public and government review period provided. Deadline for comments 30 June 2003.
- 16, 17, 19 June 2003: Technical workshops by proponents to aid government reviewers of EIS' held.
- 8 July 2003: Participant funding of \$876,438 awarded to 11 applicants; 3 applications for funding were denied.

- 7, 8, 9 July 2003: Technical workshops by proponents held to aid funded participants and other public reviewers of EIS's.
- 10 July 2003: Adequacy Statement for further information based on comments received on EIS's issued to proponents.
- 8 August 2003: Supplemental Filing # 1 received from proponents. Distributed to TAC for review and public registries.
- 18 September 2003: DFO identifies specific information requirements for their decisions.
- 9 October 2003: PAT informs the CEC that the EIS, the NFAAT and the Supplemental Filing 1 is sufficient for consideration through the interrogatory process and the public hearing.
- 10 October 2003: Supplementary Filing # 2 submitted by proponents and distributed to TAC for review and public registries.
- 24 October 2003: PAT provides further information to the CEC regarding the ongoing cooperative review process.
- 12 December 2003: Proponents submit information on forage fish to DFO.
- 17 December 2003: The Chair of PAT provides a general response to interrogatory requests clarifying the provincial and federal environmental assessment and licensing process.
- 8 January 2004: PAT submits Analysis and Disposition of Interrogatory Questions and Clarification Response to Interrogatory Requests of the Clean Environment Commission.
- 12 January 2004: PAT submits Clarification Response to Interrogatory process Requests of PCN and CNF.
- 16 January 2004: Proponents submit Draft Fish Habitat Compensation Plan to DFO.

- 17 February 2004: CEC requests PAT to provide a panel of government representatives to respond to questions on a number of identified areas.
- 24, 26 February 2004: Proponents submit information on sediment management, fish passage and protection, a draft aquatic effects monitoring program, a summary of community questions, comments and concerns, a summary of effects on navigation and formal Application for Authorization under the Fisheries Act to DFO.
- 27 February 2004: PAT responds to the CEC February 17, 2004 request to clarify respective roles at the hearing.

Attachment 2

Technical Advisory Committee Process and Wuskwatim Members

Background

Prior to proclamation of *The Manitoba Environment Act* (1988), the environmental assessment and review of large scale Provincial projects were vetted through the Interdepartmental Planning Board (IPB). IPB was established under The Manitoba Planning Act (1975) to establish provincial land use polices and to advise government through the Provincial Land Use Committee of Cabinet on matters related to land use. As IPB was an established provincial board with wide representation of provincial departments and agencies dealing with a broad range of planning matters, it was considered to be an appropriate body to consult on environmental assessment issues, in addition to issues related to its land use mandate. For this reason, IPB's role in environmental assessment became formalized through embodiment in *The Manitoba Environment Act*.

Mandate

Specifically, Sections 10(4), 11(8) and 12(4) of *The Manitoba Environment Act* requires that following receipt of a proposal, a copy of the proposal be filed with IPB and other affected departments for their review and comment. In order to facilitate the review process, IPB is responsible to appoint appropriate staff from within their department or agency to conduct a technical review of the proposal, and submit their comments to provincial staff responsible for administering *The Manitoba Environment Act*. Provincial representation on an IPB appointed Technical Advisory Committee (TAC) varies, depending on the type of project under review. To address the *Canada-Manitoba Agreement on Environmental Assessment Cooperation*, federal departments are also typically represented on the TAC. Federal representation also varies, depending on the type of project under review. A list of current provincial and federal government department TAC representatives for the proposed Wuskwatim projects is attached.
